Giving babies a chance in life

We at New Life Home Trust UK CIO raise support for the work of our partner organisation New Life Home Trust in Kenya to rescue abandoned babies.

Since a small start with one baby in 1994, the Trust now has four baby rescue homes across Kenya caring for up to 150 babies, toddlers and children at a time.

Staff at the Trust's rescue homes nurse malnourished, sick and HIV-affected babies back to health and strength. And they seek adoptive families for each one.

A reputation for excellence

So far, the Trust has rescued more than 1,835 babies. Most of them are now in loving 'forever families'.

The Kenyan government recognises New Life Home Trust as a centre of excellence for the care of babies and toddlers. Two of the Trust's baby homes are government-registered medical centres.

A small price to pay

We want each baby to feel loved and to have the best possible chance for a new life. Saving and transforming a baby's life is costly – our sponsors' help is invaluable.

Your donations help us provide a cot and care for one baby for one month which includes:

- 210 bottles of baby formula milk
- 180 nappies
- 9 kilograms of baby laundry washed
- 24-hour attention from caregivers and nurses
- daily consultations with medical professionals
- specialised medical equipment
- medications
- hospital treatment, there's no national health service
- administrative, cleaning, kitchen and premises staff
- advice from social workers and solicitors
- 1,000s of cuddles and soothings beyond price.

It costs about £400 per month to care for one rescued baby at a New Life Home Trust home.
